## Growing the Economy. Protecting our Environment.

Over the last four years, our government has delivered on a progressive agenda that focuses on investing in people and infrastructure, growing our economy, while protecting our environment. Taking action to fight climate change is at the heart our work, including putting a national price on carbon, creating clean energy jobs, and building green infrastructure for the new economy. At the same time, we have continued to grow the economy by investing in families and communities, creating over 1.1 million jobs since 2015.

Our responsible fiscal plan also means that Canada is expected to be the second-fastest-growing economy in the G7 next year. ## **Supporting Seniors**

Our government will always stand up for seniors. That is why we have already made important investments into Old Age Security and the Guaranteed Income Supplement, restoring the age of eligibility to 65 and putting up to \$2,000 more dollars in the pockets of the most vulnerable single seniors.

I am looking forward to working with the Honourable Deb Schulte, Minister of Seniors, to continue our government's work to improve the lives of seniors.



We'd like to hear from you! Comments We know that in particular many seniors struggle with the financial hardship of the cost of their medications. With this in mind, our government was proud to announce in the 2019 Speech from the Throne a commitment to establish a National Pharmacare Plan, which will help millions of seniors and families across the country afford the medication they need.

As we work to implement this ambitious program, we will also continue key investments to support seniors, ensuring all Canadians have access to a family doctor, and by making record investments in mental health services, home and palliative care, and more coordinated community care. Seniors will see their Old Age Security benefit increase by 10 percent when they turn 75, with further rises through indexing to inflation. Seniors will also see their Canada Pension Plan survivor's benefit increase by 25 percent.

I look forward to working with the government to implement these important programs to ensure seniors have the support they need for the dignified retirement they deserve.
